Green Country USBC 71st Annual Women's Tournament

2014 Tournament Rules

- Only members of the Green Country USBC Association are eligible to bowl in this tournament. A minimum of twenty-one (21) games must have been bowled in this association for the 2013-14 season as of the date you bowl in order to be eligible.
- 2. Averages: Entrants shall use:
 - a. Highest sanctioned GCUSBC league average of the 2012-13 winter season of 21 games or more.
 - b. If a bowler has no 2012-13 winter GCUSBC book average, use current GCUSBC league average of 21 or more games in a single league as of January 1, 2014.
 - c. USBC Rule 319B. If a bowler cannot satisfy any average requirements above, she will bowl scratch.
 - d. USBC Rule 319A-2 (10 pin rule) WILL NOT apply.
 - e. USBC Rules 319D (Reporting Prior Tournament Winnings) and 319E (Average Adjustment for Entry) WILL apply.
- 3. USBC Rule 319A-3: Bowlers are responsible for verifying their own average, whether submitted by the bowler, the team captain, or others. Failure to use the proper average shall disqualify the score if the submitted average is lower than the actual average, thereby resulting in more handicap.
- Handicap will be 85% from 220 based on individual series units.
- Entries will open January 6, 2014 and will close midnight February 2, 2014. All mailed entries must be postmarked before midnight February 2, 2014.
- 6. Bowlers may bowl multiple teams:
 - a. No more than two (2) bowlers may compete together more than once in any team event.
 - b. If a bowler competes more than once in the team event, the first team event score will be used for all-events
- 7. Bowlers may bowl multiple doubles and singles.
 - a. All bowlers bowling doubles event must bowl singles the first time they participate. Multiple participation in the singles event is optional.
 - b. No doubles may pair with the same partner more than once.
 - Bowlers bowling multiple times in the singles event may only cash once.
- Entry fee shall be \$17.00 per person, per event. Entry fee
 must accompany the entry blank in form of money order or
 bank draft. NO PERSONAL CHECKS ACCEPTED. Entry
 blanks received without the full amount required will not be
 accepted. Make funds payable to GCUSBC.
- 9. Prize Fee ratio at least one (1) prize for each five (5) entries in Team, Doubles, and Singles events. Ratio shall be at least one (1) prize for every ten (10) entries in All-Events. Prize fund shall be returned 100%.
- 10. There shall be an optional all-events fee of \$4.00 for those entrants who enter team, doubles, and singles and wish to participate. All-Events prizes and awards will be on a handicap basis in each case. Any bowler who places first in the All-Events but has not entered and paid the extra fee is eligible for the Championship Trophy and chevron only.

- In case of a tie, duplicate trophies will be awarded and place monies shall be divided.
- 12. All prize checks are void after 30 days and will be re-issued.
- Bowlers must check in at the tournament desk at least 30 minutes before bowling. No score will be given for any frames missed.
- After the tournament schedule is published, no change will be permitted except for extreme emergencies.
- 15. Substitutes will be allowed. The tournament manager is to be advised, if possible, of subs at least one (1) hour before scheduled time for bowling. Subs are not required to reimburse the original entrant with the entry fee, nor is she expected to give the original entrant any prize monies or trophy won.
- 16. Teams with comparable averages will be paired together when possible. Teams wishing to bowl together must submit together and indicate so.
- 17. There shall be (3) sets of doubles to a pair of lanes unless scheduling of two (2) sets to the lanes is necessary due to time elements.
- 18. Team event will be bowled on one pair of lanes, singles on one pair, and doubles on the adjacent pair. Doubles will be bowled before singles.
- 19. Unmarried grade and high school students who have not attained the age of 18 must have written consent of their parent or guardian in order to participate in this tournament. Said written consent must be on file with the tournament director at least one week prior to bowling in the tournament, unless the student is accompanied by their parent or legal guardian, in which case the consent form may be filed up to the time the student starts to bowl (USBC Rule 13)
- In case of mechanical difficulty, bowlers will stop bowling and bowl at a later time so as not to disrupt the tournament schedule.
- 21. Automatic Scoring is the official score. Changes must be made by a designated tournament official.
- 22. USBC Rule 329 (Protests). Protests involving eligibility or playing rules must be made to tournament management in writing within the time limits in Rule 329. The decision of tournament management will be final unless a written appeal is filed with USBC Headquarters within the time limits in Rule 329.
- 23. Entries are to be mailed or given to: Travis Turner, 2604 Rutherford St., Muskogee OK 74403 or a designated representative. No entries are to be left at the bowling establishments.
- 24. No pacers will be allowed.
- 25. Practice bowling must stop 30 minutes before tournament bowling begins.
- 26. No flash photography is allowed during the scheduled bowling.
- No children will be allowed in the bowlers' area. No nursery will be provided.
